PLAN 58M-279, PT BLOCK 59 AND BLOCKS 60 TO 66



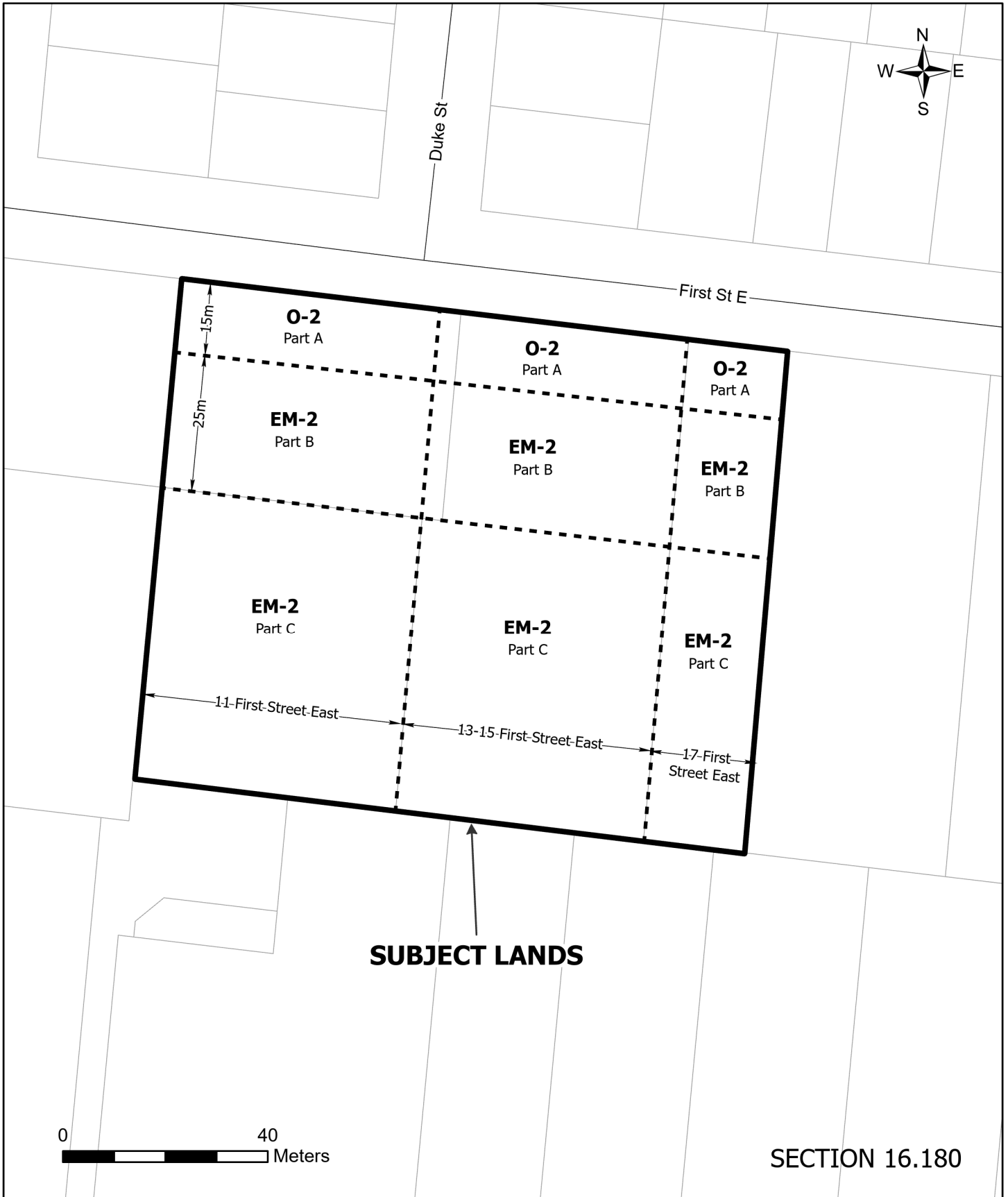

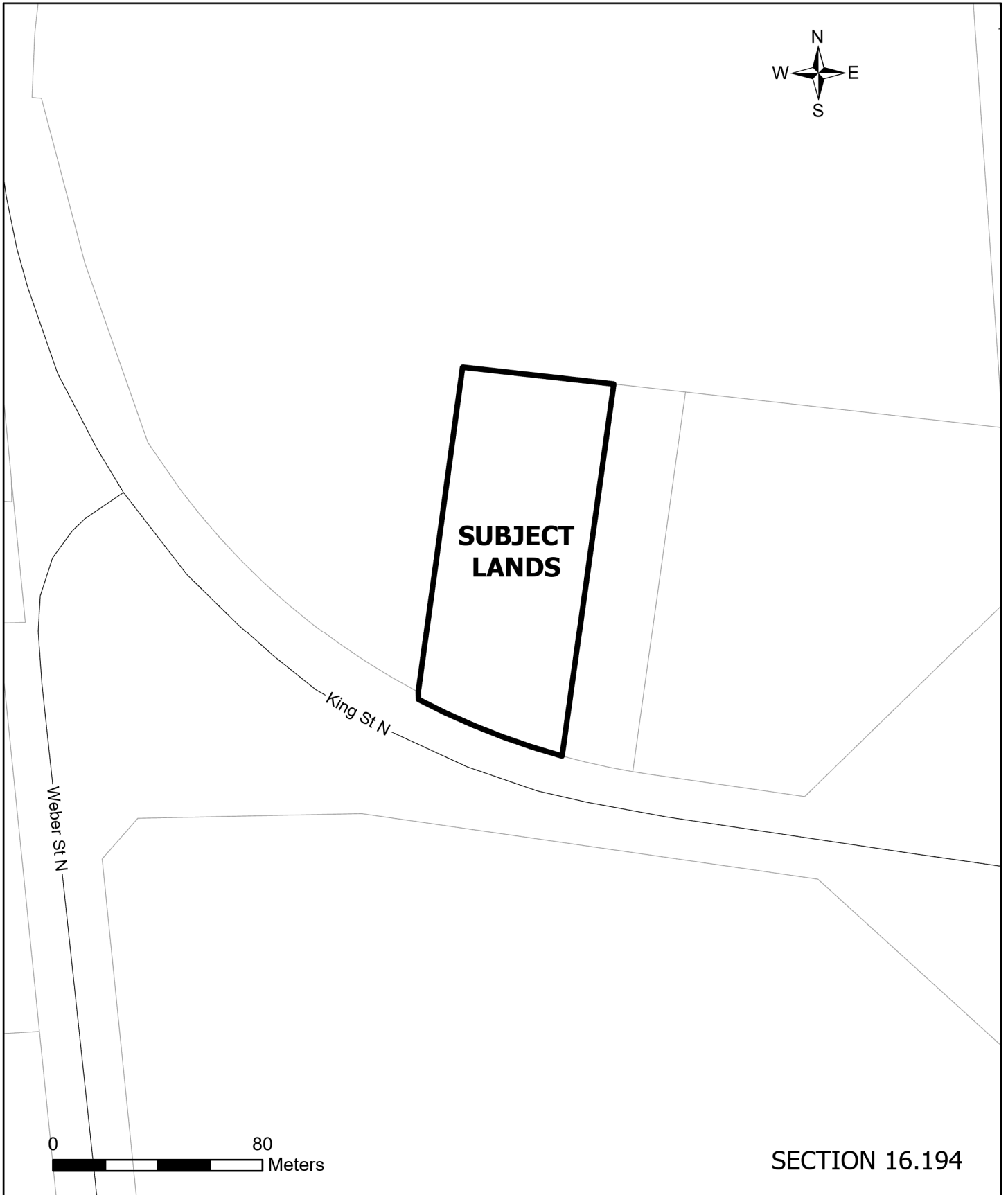
Church Street West, Robb Road and Poffenroth Path (Woolwich Holdings) Subdivision
